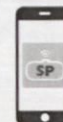

**Account Number:** Your billing and payment account number with Superior Propane.  
**Invoice Number:** A unique number detailing purchases made since your last invoice.  
**Invoice Date:** The date this invoice was generated and posted to your account.  
**Current Invoice Total:** The total of all new charges.

**Easy Payment Options**

We now have many convenient payment options to suit your busy schedule.

- Monthly Pre-authorized Bank or Credit Card payment automatically charged 15 days after invoicing or through equal monthly payments. Call our Customer Service number for details.
- At most banks and financial institutions either by ATM, over the counter, by phone or the internet.
- Mail in your payment and remittance slip using the envelope provided with your invoice.

**Please make cheques payable to Superior Propane. Do not send cash through the mail.**

**Moving**

When moving or cancelling service, please give us 48 hours' notice, as you are responsible for all charges until service has been cancelled. You can arrange for service by calling our Customer Service number. Following your move, the Tank Pick-Up Fee will not be applicable if the new owner chooses Superior Propane as their supplier.

**Tank Pickup**

The cost of retrieving rental tanks is not included in the price of propane. Therefore, a Tank Pick-Up Fee applies if you no longer require our tanks.

**Paying your Invoice on time**

Avoid a late payment charge by paying your bill before the 'due date' shown on the front of this invoice. This charge is calculated at a compound interest rate of 2% per month (26.82% per year). As well, there is a \$25.00 charge for any cheque returned due to insufficient funds.

**Other Fees/Charges**

The Transportation Fee offsets transportation related costs from the Superior Propane distribution centre to the customer such as vehicle maintenance, licensing, labour, insurance, and baseline diesel fuel and gasoline costs. The Hazardous Materials Handling Fee offsets the cost of ensuring Superior maintains the highest industry standard in all aspects of hazardous materials training, certification and emergency response processes. The Fuel Surcharge has been implemented as an extra-ordinary charge on all deliveries to transparently address the unexpected and rapid growth in diesel costs incurred from the Superior Propane distribution centre to the customer. We believe reflecting these fees separately on your invoice is a fair and transparent way of showing our customers our costs of doing business. These fees are subject to increase without notification.
